Judging will start no earlier than 8 AM each day—Your Final Confirmation and Trial Information, emailed after the close of the trial, will provide details on start times each day.

NOTE: To avoid ring conflicts for Master Standard and JWW so that the same height is not running simultaneously in both rings, we will most likely shift the height running order for those classes in one of the rings (probably the JWW ring.)

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

#### **DOG ELIGIBLE TO ENTER**

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

#### **DIRECTIONS TO THE TRIAL SITE**

# Coming from North or South on GA 400:

Exit GA 400 at Exit 10 (Old Milton Pkwy / GA120). Turn West on Old Milton Pkwy (Left turn if coming from the South, Right turn if coming from North). Continue past GA Hwy 9 (Main St) to Wills Road. Turn Left on Wills Road and Equestrian Center is on Right.

# **Coming from West:**

From Hwy 92, turn Left onto Hardscramble Rd (at Target shopping center). Continue until it ends at Crabapple Road and turn Left. Immediately turn Right onto Rucker Rd and continue to Wills Rd. The Equestrian Center is on the Left.

# **Coming From East:**

From Pleasant Hill Rd/States Bridge Road/Old Milton Pkwy – Cross over GA Hwy 9 (Main St) turn Left on Wills Rd. Equestrian Center is on the Left. From Holcomb Bridge Rd – Proceed to GA 400 and follow North/South Directions above.

#### **OBSTACLES AND RING CONDITIONS**

Obstacles meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Two rings,  $100' \times 100'$ , outdoors, under cover, on packed dirt. 24'' spaced weave poles, rubber contacts, plastic jumps, displaceable tire, and electronic timers are used. There will not be a wall jump.

#### WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in the next class only and will be limited to a maximum of 60 handlers per AKC rules. Handlers with multiple dogs/conflicts may walk with a different jump height if needed. Tell the gate-steward if you need to move your dog, they will help you manage your conflict.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

**RINGSIDE** - Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

# **ENTERING FOR EXHIBITION ONLY (FEO)**

- For Exhibition Only is being offered at the option of the host club. FEO allows exhibitors to work with their dogs in a trial environment. As of July 1, 2024 FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may also be declared when checking in at the gate board but it is still the competitor's responsibility to insure FEO is declared to the judge.

# **FIX AND GO ON (FNG)**

Fix and Go On (FNG) is not pre-entered; rather, it occurs during the course of the run. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. The competitor need not signify their intention to the judge. The judge will declare FNG when they see it being executed.

# **MOVE-UP REQUESTS**

Move-ups must be sent in writing (e-mail is acceptable and preferred) to the Trial Secretary for the Friday September 6, 2024 trial, no later than Monday, September 2, 2024, by 6:00 PM. Move-ups from Friday to Saturday, Saturday to Sunday must be submitted to the trial secretary no later than 15 minutes after the last class on Friday and Saturday.

# ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND – MULTIPLE JUMP HEIGHTS WITHIN THE SAME TRIAL DAY

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

#### MEASURING AND HEIGHT CARD INFORMATION

Jump height cards are not required to be submitted with the entry form. However, ALL entered dogs without a valid Jump Height Card must be measured by the Volunteer Measuring Official (VMO) Judge Michele Fletcher before the dog's first run of the trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

The "height at withers" box on the entry form MUST be filled in with dog's height at withers. You must declare an <u>estimated</u> height at withers if your dog needs to be measured.

# **AKC RULES AND REGULATIONS**

All exhibitors should obtain a copy of the Regulations for Agility Trials by downloading them from the American Kennel Club website at http://www.akc.org/rules/.

#### REFUND INFORMATION

**Bitches in season** are not permitted at the trial. Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded the entry fee, less \$5 per run/each day, upon written certification from a veterinarian. Refund request must be received by the trial secretary no later than 30 minutes before the start time on the first day of the trials.

**Injured Dogs** – Will be refunded the entry fee less \$5 per run/each day, upon written certification from a veterinarian (on clinic letterhead). Refund request must be received by the trial secretary no later than 30 minutes before the start time on the first day of the trials.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

# **NOTICE TO EXHIBITORS**

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

Canine Capers Dog Agility Club, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.

#### **PRIZES AND AWARDS**

Rosettes are awarded to the 1st through 4th place teams in each jump height in each class. Dogs must qualify to receive placement ribbons. Qualifying ribbons are awarded to all dogs receiving qualifying scores. Teams earning a title receive a New Title rosette. MACH and PACH rosettes and bars are awarded to dogs that earn those titles at this trial. All ribbons must be claimed by the end of the Trial; none will be mailed.
